Introduction

This introduction is not part of the Food Notice, but is intended to indicate its general effect.

Purpose

The purpose of this Food Notice is for the chief executive (CE) of the Ministry for Primary Industries (MPI) to approve the GLOBALGAP standard developed by the GLOBALGAP as a food control plan template under section 40.

Background

The purposes of the Food Act 2014 (the Act) include achieving the safety and suitability of food for sale, maintaining confidence in New Zealand's food safety regime and providing for risk-based measures that minimise and manage risks to public health.

The Act requires some food businesses to operate under a registered food control plan (FCP) to ensure that food produced by that business is safe and suitable.

Section 40 of the Act allows the CE of MPI to:

- approve templates or model FCPs developed by people other than the CE for up to 3 years;
- set conditions subject to which approval is given;
- issue a new Notice approving a template or model for a further period of up to 3 years;
- issue a Notice suspending or withdrawing approval of a template or model.

The template approved by this Food Notice has been approved by MPI as it meets the requirements of the Act. MPI is satisfied that the template if followed as written will enable food businesses to significantly control the relevant food safety hazards associated with growing, harvesting and undertaking of minimal processing of horticultural produce. In particular, the template identifies:

- hazards that are reasonably likely to occur;
- · appropriate controls for those hazards;
- steps for monitoring of appropriate limits;
- what to do when situations arise that require corrective actions.

The approval for this template expires 3 years from the date that this Notice is issued. Before this date, food businesses operating with the template can apply for renewal of approval for a further period of 3 years.

Who should read this Food Notice?

This Food Notice applies any business that is certified by GLOBALGAP or authorised by GLOBALGAP to use this template to register an FCP under Food Act 2014 based on the GLOBALGAP Standard approved by this Food Notice.

Why is this important?

The Template is based on the GLOBALGAP Standard (a model) that food business can use to manage the safety and quality of products made within the horticultural environment. This template is specifically developed for growing, harvesting and undertaking of minimal processing of horticultural produce. It can only be used by a business that is certified and/or authorised by GLOBALGAP.

If a business is eligible to use this template, the business may register a FCP based on this template. If a food business opts to register an FCP based on the template, the business cannot amend the template or add additional material to the template.

A food business that registers an FCP based on this template is responsible for ensuring that its operations are verified by a person or agency who is recognised to verify template food control plans for horticultural businesses involved in growing, harvesting and undertaking of minimal processing of horticultural produce.

Part 1: Requirements

1.1 Application

(1) This Notice applies to any business that is certified by GLOBALGAP, or authorised by the GLOBALGAP to use the standard or model.

1.2 Definitions

(1) All terms used in this Notice that are defined in the Food Act 2014 (the Act) or Food Regulations 2015 (Regulations), but not defined in this Notice, have the same meaning as that defined in that Act or Regulations.

1.3 Approval of template

- (1) The template entitled Food Control Plan Template (GLOBALGAP) and dated August 2018 is approved under section 40 of the Act.
- (2) Approval for this template ends 3 years from the date that this Notice is issued.
- (3) The reference number for this template is S40-00006.
- (4) The template may only be used for growing, harvesting, sorting, grading and undertaking minimal processing of horticultural produce activities at a horticultural business.
- (5) The template may only be used by businesses certified by GLOBALGAP or authorised by GLOBALGAP to meet registration requirements for Food Act 2014.
